It was setup in 2007 as a resource agency to catalyze the growth of the community led microfinance (Self-Help Group model) and livelihoods in Rajasthan. To achieve these, CmF provides technical and knowledge support to government programmes, non-government organizations, community institutions and banks. It also supports innovative ideas, which seek to increase outreach of microfinance services to underserved regions and populations. Another core activity of CmF is to serve as a knowledge hub on community-led microfinance and livelihoods. Networking and promoting collaborations among various stakeholders to further the microfinance sector in the state is another core objective of CmF. About the Programme:

CmF is working with the state government promoted Society namely Rajasthan GraminAajeevikaVikasParishad (RGAVP) to develop livelihoods clusters (agriculture, dairy and goat based livelihoods) in 20 blocks of 9 districts wherein RGAVP has promoted Self-Help Groups and Federations. The specific objectives of the CmF-RGAVP partnership are as follows:

- 1. To facilitate additional income to SHG families in the range of Rs. 40,000 to 60,000 through market linkage development in agriculture and allied (livestock) activities
- 2. To develop and build capacities of SHG women as community service providers for efficient and sustained delivery of extension services in agriculture and livestock
- 3. Promote 8-10 community based livelihood organisations (producer companies/cooperatives) and strengthen existing producer companies/cooperatives promoted by RGAVP to lead market led livelihood interventions in the project blocks
