Invitation for Expression of Interest (EOI) for empanelment of agency for Conducting Impact Assessment Study (IAS) for Mitigating Poverty in Western Rajasthan (MPoWeR)

### BACKGROUND

Centre for microFinance (CmF), Jaipur ([www.cmfrj.org](http://www.cmfrj.org)) is a resource organization working in Rajasthan since 2007 to catalyse the growth of community based microfinance and livelihoods sector in the state. It works with multiple stakeholders such as government programs, non-government organizations (NGOs), banks, community organizations (especially Self-Help Groups and SHG Federations) and donors to enhance the quality of life of the poor in Rajasthan. CmF is also the nodal agency of the Tata Trusts ([www.tatatrusts.org](http://www.tatatrusts.org)) for Rajasthan and is responsible for quality implementation of Tata Trusts' supported projects under their Sakh-Se-Vikas (SSV) initiative. The Tata Trusts and Dept. of Rural Development and Panchayati Raj, Govt. of Rajasthan signed an MoU in September 2008 wherein CmF was appointed as the nodal agency of the Trusts for the MPoWeR to provide technical and knowledge support to MPoWeR.

The Department of Rural Development and Panchayati Raj, GoR has been implementing the Mitigating Poverty in Western Rajasthan (MPoWeR) in the six western districts of Rajasthan. The project was funded by IFAD, Tata Trusts, GoR and the beneficiaries. The project completion is due by Dec 2017. In this respect, on behalf of MPoWeR, CmF is inviting proposals for carrying out an Impact Assessment Survey in accordance with the ToR. The duration of the consulting services will be about TWO calendar months and the services are expected to be performed by a team of experts and specialists.

3.	The agency, having a turnover of INR 10 Lakhs – Average of last three years would be preferred.	Copy of audited statement of accounts of last three years.
